Community Development and Planning Director Rachel Roberts stepped forward and asked council if they would consider changing from the Burleson Star to the Fort Worth Star Telegram. She explained that the Star Telegram has several papers printed each week as compared to the once a week printing of the Burleson Star and it would be easier to get notices published. She also informed them the rates for the Star Telegram and the Burleson Star were comparable, but that by signing a contract with Fort Worth, we would not be allowed to use any other newspaper. City Manager Loftin also added that the thought by the local government code, the Burleson Star no longer met the definition of an official publication of local circulation because it was no longer charging for their paper. Council agreed they would be interested in seeing a contract and stated that staff could move forward in getting a contract and resolution to be presented at another meeting.

## CITIZEN AND VISITOR PARTICIPATION

Mayor Davis asked if there were any citizens or visitors wishing to speak.

Daniel Bennett, White Settlement, TX, previous candidate for Tarrant County Appraisal District (TAD) Board of Directors. He stepped up to discuss his findings regarding the 2015 TAD Board of Directors Election. He showed council two different documents sent to him by TAD; the first document was the results of the 2015 TAD Election which showed tabulations which differed from the individuals listed as winning the election; the second was a new letter sent by TAD which was not signed and showed corrected numbers for the election which did match the winning candidates. His concerns were that the 2015 election was not run correctly and that TAD allows the larger voting entities such as the City of Fort Worth and the Fort Worth ISD to vote as the last minute (or even after the deadline has passed) in order to ensure the individuals they want on the TAD Board of Directors. He also wanted to thank council for their support and votes.

## ITEMS OF COMMUNITY INTEREST

Mayor Davis asked if there were any community interest items.

Council Member Christine Gilbreath informed everyone that her husband, Scott Gilbreath has returned to the state from recent deployment.

Council Member Jesse Johnson stated his concerns regarding the City of Fort Worth and the Fort Worth ISD waiting till the last minute to cast their votes for the TAD Board of Directors. City Manager Robert Loftin made the suggestion to add this discussion to a later work session to discuss some possibilities or resolutions to prevent this from reoccurring in upcoming elections.

Council Member Johnny Shotwell mentioned that a previous Grand Marshall of one of the City's parades had recently passed away and asked we keep his family in our prayers.

Matt Foster, recently purchased Crowley Tire and Auto Service and he wanted to introduce himself to the council.
