- 1. Presentation of City of Crowley Economic Development plans/projects by Jack Thompson (Assistant City Manager/Economic Development Director).**

Assistant City Manager/EDC Director gave a presentation on the City of Crowley future plans and projects. He discussed the Main Street Project, Atwoods development, and briefly discussed the possibility of a planned development called Karis.

Mr Anthony Kirchner gave a presentation on the Crowley ISD. He discussed the growing attendance, new elementary school ground breaking, and the future Career and Technology Education Building.


- 3. Presentation by Nehemiah on possible future land development.**
